TRANSPARENCY DECLARATION RULES

All ERA-EDTA Council candidates, at the time of submitting their candidature, must make a formal declaration of any potential conflict of interest of amounts received within one year (i.e. last 12 months from time of submission).

Such declarations may include, but are not limited to, shareholding in or receipt of a grant, travel award or consultancy fee from a company whose products are in the fields of interest of the applicant and/or the Association itself.

We suggest that candidates concentrate on transparency declarations (i.e. conflicts of interest) of a financial nature, although relevant non-financial disclosures can also be made on a separate sheet of paper and sent together with all the relevant documentation.

Candidates should either tick the appropriate declarations or state “NO” (i.e. nothing to declare).

The amount declared should be the total amount received, for that specific item, in the last 12 month period. In case of shareholding, the amount to be taken into consideration will be only in excess of EURO 20.000.
