## CME COURSE TRAVEL

### GRANTS RULES AND REGULATIONS

a) **WHAT THEY ARE.** The ERA-EDTA offers **2 travel grants of EURO 500.00** to nephrologists that are less than 35 years old and early in their career, plus one year ERA-EDTA membership (including free access to NDT Online and the right to pay a reduced registration fee to the annual ERA-EDTA Congresses).

b) **WHO DOES THE SELECTION.** The local Course organizers will be in charge of deciding who will receive these Grants, with the only provision that the winner must not be older than 35 years of age. The applications will be sent to the local Course organizers by the ERA-EDTA Operative Headquarter. The ERA-EDTA Operative will send a notification of travel grant winning shortly after receiving the course organizer's evaluation.

c) **HOW TO REQUEST/RECEIVE THEM.** In order to request these Grant the applicants must fill in the "CME Course Travel Grant Application Form" and send it to the ERA-EDTA Operative Headquarter (address: ERA-EDTA Operative Headquarter, Via Spolverini 2, 43126 Parma, Italy, e-mail: [education@era-edta.org](mailto:education@era-edta.org), fax: +39-0521-959242) together with a curriculum vitae, a photocopy of a personal ID (passport, ID card, driver's license) and a signed official letter from the head of department by **October 5, 2009**.

**The Grant Winners (ONLY) will receive an official notification from ERA-EDTA Operative Headquarter.**

After the Grant Winner is informed about this by the ERA-EDTA Operative Headquarter he/she must send an "Application Form for Membership in the ERA-EDTA" completely filled in to the ERA-EDTA Membership Office (address: via Aldo Moro 18 - 35030 Bastia di Rovolon (PD), Italy). This form can be downloaded from the ERA-EDTA website: go to [www.era-edta.org](http://www.era-edta.org) and click on "Membership" from the menu on the left.

The "Application Form" must be sent no later than one month after the Course. "Applications" received after this deadline will not be taken into consideration.
